## Response by Cyfoeth Naturiol Cymru/Natural Resources Wales

Thank you for consulting Natural Resources Wales (NRW) on the above matter.

We work as a regulator, partner and advisor to businesses, non-governmental organisations, Local Authorities and communities to help deliver Welsh Government and European Union policies and priorities. We take an ecosystem approach to promoting sustainable development that delivers social, economic and environmental benefits to the people of Wales.

Of relevance to this consultation, Natural Resources Wales has powers to make byelaws transferred from its legacy body, Countryside Council for Wales. We have a limited number of instances where byelaw powers relevant to this consultation are used. We continue to value the availability of such powers as part of the tools we have available to support our work e.g. in relation to Skomer Marine Nature Reserve we feel they provide an effective deterrence. However, we often use alternative, stronger powers within legislation to pursue similar ends.

The guidance provided is generally clear and helpful in relation to the processes and practice required for the use of relevant byelaw making powers. In relation to the proposed Order and byelaws that do not require confirmation by the Minister, we do not wish to make additions to the list included in Schedule 1 at this time.

Our comments to the specific consultation questions are included below.
