Statutory Guidance about sewerage undertakers duty to connect properties to the public sewerage system *under Section 101A of the Water Industry Act 1991)

Thank you for the opportunity to comment on the consultation regarding revisions to the Statutory Guidance about sewerage undertakers duty to connect properties to the public sewerage system Section 101A of the Water Industry Act 1991.

We have set out our comments according the headings within the guidance to which they relate:

3.3 Mobile homes and fixed caravan sites

We agree that provision of guidance on considerations to take into account when determining if the s101A(1) obligation applies to sites containing fixed caravans and mobile homes is a positive step forward over the original 1996 Statutory Guidance.

It is regrettable however that the clarity and scope included in the revised guidance published in July 2014 has been lost and a greater degree of subjectivity has been introduced. This may result in potential for an increased occurrence of disputed duty decisions.

The revised guidance was not specific in the type of caravan and therefore suggested inclusion of touring caravan sites which contain permanent structures such as toilet blocks and washing facilities. The consultation guidance only makes reference to sites containing mobile homes and fixed caravans.

It is unclear what is meant in terms of consideration of the amount of time in a given year that the fixed caravan or mobile homes are occupied. Does this mean that sites unoccupied for periods of the year would be less likely to come into scope for s101A than sites with permanent occupancy? It is our contention that sites inherent of sporadic sewage loading due to seasonality may result in difficulties that are not easily remedied by private treatment options and may well benefit from inclusion in s101A schemes.
