Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

Schedule 1 to the Environmental Permitting Regulations has been updated by the Environmental Permitting (England and Wales) (Amendment) Regulations 2013 to reflect the implementation of the Industrial Emissions Directive into England and Wales.

As a result of this, a number of previously permitted waste activities have now been amended to schedule 1 listed activities. These activities are referred to as 'newly prescribed activities'.

This variation is to add the following newly prescribed activity to the permit and subsequently vary the regulated facility from a waste facility to an installation: S5.4A(1)(b)(i), recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day (or 100 tonnes per day if the only waste treatment activity is anaerobic digestion) involving biological treatment. Natural Resources Wales has also taken this opportunity to produce a consolidated permit in the modern 'EPR' format.

The existing waste facility, 'combustion of biogas in one combined heat and power (CHP) engine with an electrical aggregated thermal input of 3.456 MWth', remains in the permit as a separately listed waste activity and is not altered by this variation.

The schedules specify the changes made to the permit.
