### **Introductory note**

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

The Industrial Emissions Directive (IED) came into force on 7<sup>th</sup> January 2014 with the requirement to implement all relevant BAT conclusions as described in the Commission Implementing Decision. The iron and steel manufacture BAT conclusions were published on 8<sup>th</sup> March 2012 in the Official Journal of the European Union following a European Union wide review of BAT.

This variation incorporates the changes required by the Industrial Emissions Directive following a statutory review of permits in the iron and steel production sector. This includes the amendment of the wording of several permit conditions relating to notifications and also includes the addition of a condition relating to a requirement for monitoring of groundwater and soil. This permit variation also includes the addition of specified waste storage on-site.

The addition of a number of waste streams have also been added to the permit – to include SRF, ASR, EOLT, plastics and scrap metal.

The schedules specify the changes made to the permit.

The status log of a permit sets out the permitting history, including any changes to the permit reference number.
