In Wales NRW is the licensing authority for issuing licences under section 16 of the Wildlife and Countryside Act. We agree that it would be appropriate to amend the relevant sections of the Wildlife and Countryside Act to ensure compliance with AIHTS and to include stoat and beaver on a new Schedule to the Act. Use of a 'general licence for stoats' would seem to be an appropriate approach to minimise legislative burden. NRW does not have 'class licences' but we will consider the need for equivalent licences on a case by case basis.

However, there is a small group of organisations (eg conservation groups and university researchers) who trap some of the species mentioned in paragraph 39a (pine marten, beaver) and they will have limited resources to replace cage traps that are considered to be non-compliant. NRW recommends that Defra work with these groups to establish whether data can be collected to approve traps currently in use.

As noted above in the answer to question 2, there is a group of organisations concerned with trapping some of the other species, particularly pine marten and beavers. Whilst this is small scale compared to trapping of stoats, the impact on these groups should be acknowledged. To prepare for implementation of AIHTS in the UK there will need to be an awareness raising campaign, particularly around the changes in the law on trapping stoats. It will also be important that information is readily available on approved traps and that there is a ready supply of such traps.
