

## General Data Protection Regulation (GDPR)

The Welsh Government will be data controller for any personal data you provide as part of your response to the consultation. Welsh Ministers have statutory powers they will rely on to process this personal data which will enable them to make informed decisions about how they exercise their public functions. Any response you send us will be seen in full by Welsh Government staff dealing with the issues which this consultation is about or planning future consultations. Where the Welsh Government undertakes further analysis of consultation responses then this work may be commissioned to be carried out by an accredited third party (e.g. a research organisation or a consultancy company). Any such work will only be undertaken under contract. Welsh Government's standard terms and conditions for such contracts set out strict requirements for the processing and safekeeping of personal data.

In order to show that the consultation was carried out properly, the Welsh Government intends to publish a summary of the responses to this document. We may also publish responses in full. Normally, the name and address (or part of the address) of the person or organisation who sent the response are published with the response. If you do not want your name or address published, please tell us this in writing when you send your response. We will then redact them before publishing.

**Q3:** It is intended that minor alterations to heritage partnership agreements will not trigger the publicity and consultation requirements specified in:

- regulation 5 of the draft Listed Buildings (Heritage Partnership Agreements) (Wales) Regulations 2021
- regulation 4 of the draft Scheduled Monuments (Heritage Partnership Agreements) (Wales) Regulations 2021

The draft guidance, heritage partnership agreements in Wales, expands on these requirements in paragraph 3.10. Can you provide examples of changes that you believe heritage partnership agreements should be able to accommodate without requiring full publicity and consultation?

- We envisage that minor amendments via e-mail agreement would be sufficient in such cases where site features may require rapid stabilisation to secure the site condition due to natural collapse (i.e walls and banks) and to safeguard public safety.
  - To provide alternative safe routes for public access/safety due to the above or when carrying out agreed maintenance.
  - While carrying out harvesting operations near to the site as per our coupe planning protocol for enhancing the site setting.
  - Minor works for site sensitive management on features within National Nature Reserves and Designated Sites on the Welsh Government Estate.

We have our own formatted Scheduled Monument Plan Agreements with Cadw, however, if entering into a partnership with third party, this agreement would be used as the basis for the partnership framework.

Under our annual revised Cadw, WAT's and NRW MOU, we acknowledge that option 4 further complements our current agreement structure. The MOU would accommodate a further partnerships agreement.

NRW has a welsh language policy that provides support for staff development to learn Welsh. We believe through our staff development; this helps to integrate and enhance the Welsh language.  
Our policy extends to providing leaflets and interpretation boards bilingually across all our managed estate. We therefore hope that NRW policy contributes positively to the Welsh language and any potential projects through partnerships.
